

## HEALTH SAFETY AT SLUSH 2021

Slush commits to organising an event with high health safety standards in Dec 1-2, 2021. Below you find listed the health security measures in place during Slush 2021.

Proof of full vaccination series, recovery from Covid-19 less than 6 months prior to the event, or a negative PCR test result

We reserve the right to inspect our visitors' Covid-19 passport if changes in the legislation or decisions and guidelines on the part of the authorities require or permit us to do so.

Accordingly, in order to enter Slush 2021, you may need to present proof of one of the following:

- A full course of an approved Covid-19 vaccine with the last vaccine taken at least 14 days prior to the event. See the list of approved vaccines in Finland below.
- Proof of recovery from Covid-19 less than six months prior to the event.
- Proof of negative PCR test within 72 hours of entrance.
  - Please note that a proof of a negative PCR test result will be checked on both event days, so in order to enter the venue with the same test result on Slush Day 2, your negative PCR test result should not be more than 48 hours old on Slush Day 1.
  - Please note that a proof of full vaccination series, recovery from Covid-19 less than 6 months prior to the event, or a negative PCR test result is required also from the visitors attending Slush organised Side Events on Slush Day 0, like Founders Day and Investor Day. In order to enter the main event venue with the same test result on Slush Day 2, your negative PCR test result should not be more than 24 hours old on Slush Day 0.

We accept [The EU Digital COVID Certificate](#) as proof of each of the above. For attendees traveling from outside the EU, we accept comparable national/regional covid certificates, like

- UK: [NHS Covid Pass](#)
- California: [Digital Covid-19 Vaccine Record](#), or a physical vaccination card
- New York: [Excelsior Pass, NYC Covid Safe App](#), or a physical vaccination card

In any case, we strongly recommend our visitors to be prepared to present a covid certificate.

The covid certificates will be checked upon entrance to the event venue.



### **List of approved vaccines in Finland:**

You have been fully vaccinated if you have received all the required doses of vaccines accepted in Finland at least 14 days before the event: Comirnaty (Pfizer-BionTech), Spikevax (Moderna), Vaxzevria (AstraZeneca), Janssen (Johnson & Johnson), BIBP/Sinopharm, COVISHIELD (Serum Institute of India), CoronaVac (Sinovac Life Sciences). In addition, we are currently exploring the opportunity of requiring negative Covid-19 antigen tests from all of our event attendees before entering the venue. Should that be the case, Slush provides free antigen tests and testing facilities upon entrance to the event.

### **TRAVELING TO FINLAND**

#### Traveling to Finland with a full course of an approved Covid-19 vaccine

Currently you can enter Finland from all countries if you have received a full course of an approved Covid-19 vaccine at least 14 days prior to entering the country, while taking into account the provisions on the entry of foreign nationals into Finland, e.g. visa requirements. #### Traveling to Finland without a full course of an approved Covid-19 vaccine

For visitors travelling without a full course of an approved Covid-19 vaccine, we recommend checking the entry restrictions that apply to your specific situation [here](#).

Please note, that traveling to Finland from the UK, the US, Russia and Turkey without a full course of an approved Covid-19 vaccine is currently possible only for essential reasons. Find more information [here](#).

If you have connecting flights, please make sure you're aware of the potential entry restrictions in the country of your layover.

### **MASKS IN THE EVENT VENUE**

As of now, we expect all participants to wear masks in the Slush venue. Slush will provide masks free of charge for the event attendees.

### **HIGH HYGIENE STANDARDS**

Slush commits to high hygiene standards during the event, including but not limited to, reinforced cleaning, generous hand sanitiser supply, no handshakes -policy, wireless payment options, and people flow design. Slush is continuously exploring ways of mitigating health risks during the event.
